## On the Agenda

### Election for Board of Director positions

The Association's by-laws require Board elections every two years. Accordingly, we will hold the next election at the November meeting. The by-laws impose term limits, so all five positions are up for election. Nominees are currently under consideration and we could really benefit from additional neighbor participation.

HHVCA's purpose is to promote our neighborhood's wellbeing and protect HHV from initiatives that do not serve our interests. The Board's role is to provide a critical link between HHV neighbors and others - individuals, groups and local government - in pursuit of matters affecting HHV. ### Paul Spring Restoration Project

Fairfax County's Stormwater Planning Department has notified HHVCA of its plan for Paul Springs Stream restoration. They are in the earliest stages of the project, performing initial scoping of the project area to assess the potential benefits. In addition, they will be reaching out to property owners in the proposed project area to gauge their interest in granting the easements necessary for implementation of the project.

The Stormwater staff will be at our November meeting to present and discuss the proposed project.
