HHV TRAFFIC SAFETY

Does it seem like every newsletter published in the recent past speaks to traffic safety? The answer is yes, because the issues continue, lack effective resolution, and if NextDoor postings are accurate, in some cases lead to personal confrontations involving police intervention.

Of the several traffic safety concerns in HHV, slowing drivers down is first on the list. Speeding occurs on every street in the neighborhood, but on our most heavily traveled streets - Shenandoah, Wellington, and Paul Springs - the problem is out of control.

Speeding is so common that our neighbors there have come together to push for specific solutions.

Speed bumps are under consideration and "Slow Down" signs are popping up all over.

Installing traffic calming devices and

raising public awareness -- i.e. speed bumps and signage -- are two of many methods used to stem speeding problems in neighborhoods.

Another is speed limit enforcement, something that occurs infrequently on HHV roads. An internet search reveals other ideas on devices, awareness, and enforcement used to slow down local lead-foots. Immediate solutions are needed on our three "speedways" and the initiatives underway will help address those specific problems. In addition, a neighborhood-wide discussion of options is needed leading to integrated plan of action. Solutions should be planned and implemented in a way that best serve the entire neighborhood. Solving this problem will require continued interest and action by the entire neighborhood. Please contact Leo if you are interested in helping address the issue.

CAN THEY DO THAT? IS THAT LEGAL?

The County's Office of Code Compliance mission is to protect the lives, property and environment of our community.

They handle complaints related to property maintenance, unpermitted construction and other zoning and building code violations, including outdoor storage and multiple occupancy issues. At a recent MVCCA meeting, County staff told attendees that the office is entirely reactive and responds only to complaints they receive regarding suspected violations. While being proactive would be a plus, the office does make reporting easy through its website. Reporting a suspected violation can be done anonymously.
