

What are the effects on youth of alcohol use?

Effect on youth



- 3.500 youth under 21 die from alcohol use each year; 66 in Maryland
- Top causes of death in youth: homicide, suicide, MVCs
- Acute health effects (poisoning, pancreatitis)
- Societal effects (crime including assault, lost work productivity)
- Harms to others (child maltreatment, domestic violence)
- Chronic health effects (liver disease, cancer)












What are the trends in alcohol use in Maryland over time?




Past Month HS Alcohol Use by Demographics, US & MD, 2019, YRBS





Past Month HS Binge Alcohol Use by Demographics, US and MD, 2019, YRBS




What do we know about the impact of alcohol during this pandemic?

COVID experience with alcohol

- Research from previous epidemics—swine flu, SARS
- Stress, isolation, boredom—triggers for alcohol use
- More leisure time, fewer alternative activities may lead to increased use
- Alcohol weakens the immune system response
- Alcohol sales 10-20% higher in March and April 2020 than 2019 (NIAAA, 2020)
- Relaxation of regulation—home delivery, cocktails to go
- Relaxation of enforcement—not checking IDs for curbside pickup, suspension of inspections

Drinking Alcohol When Working from Home



COVID and Alcohol: Research

- 1/3 of Americans drinking more now than before the pandemic
 - 1/3 working from home reported drinking during working hours
- Parents who feel stressed about distance learning drank 7 more drinks a month than those who did not feel stressed
 - These parents are also twice as likely to report binge drinking
- Average # of drinks/day and binge drinking rose 26-27% between Feb and April
 Largest rise was in households with kids at home
- 14% increase in alcohol use; 41% increase in heavy drinking in women

Overall effects

Short term effects

- Impact on youth at home through domestic violence, child maltreatment
- Impact of alcohol on the immune system in responding to COVID-19
- Additional risk factor for depression, suicide

Long term effects

- For those who are drinking moderately, could lead to escalation into alcohol abuse or dependence
- Longer term health effects from increase in consumption
- Modeling of unhealthy drinking behaviors?



ACCEPTED FAKE ID

Asked for ID 8

REASONS GIVEN

- The date of birth made them old enough (4)
- Didn't even think it could be a fake
- He was a big guy, so I figured he was old enough
- His forehead matched
- Person looked similar to ID photo

Ignoring the Facts

Verifying a Genuine ID in the New Normal

Key Techniques

- 1. ASK questions.
- 2. **INSPECT** the ID for lamination defects.
- 3. **EXAMINE** the signature font.
- 4. COMPARE signatures.

The New Normal

- 1. ALWAYS employ the Key Techniques.
- 2. ADDRESS the facemask challenge.
- 3. ESTABLISH guidelines on expired licenses.
- 4. INTEGRATE technology when possible.
