Again, Harbour Life Market is intended to augment local retailers and markets, by providing a venue that allows for the continued sale of wares during ‘off-time”, as such the market will be held every Saturday 1pm-6pm and Sunday 10am to 2pm, beginning the last week of may through to the second week of October. Black Harbour Distillery has offered a green area and a building to accommodate the Harbour Life Retail Beach Shop. This area is an ideal location for a small open-air market with a retail shop, creamery, and distillery.

The market is conveniently located on Hwy 329/Hubbards and situated very centrally to the many attractions Chester and the South Shore has to offer. Seasonal Vending Fee

- **\$125/year (includes reserved vendor stall & electricity for a nominal pre-determined fee)**

- **Guaranteed prescheduled dates for 2021 with up to 1 cancelation within 24hrs of the scheduled date**
- **If the vendor requests certain weekends to not attend, the fee will be prorated accordingly at the beginning of each season**
- **Monthly & seasonal payment options available**
- **If just a single day is requested for a certain weekend(s), the fee will be \$25 per day will be applied and total fees prorated accordingly.**
- **First right to refusal for any additional scheduled “special” events**
