RICHMOND HIGHWAY UPGRADE

VDOT plans to widen Richmond Highway to three lanes each way from Jeff Todd Highway to the Mount Vernon Highway/Buckman Road intersection, just south of Costco.

VDOT is targeting Summer 2018 for plan approval, with construction beginning in Spring 2023. Several options are under consideration, details can be found online.

VDOT's recommended option is the "Superstreet Concept". This option claims long term benefits, but would have long stretches of the highway without inter-sections, and would require U-Turns to gain access to stores on opposite side of the street. The plan also suggests that sound barriers be installed in spots along the route.

The estimated cost of the project is \$215 million: \$12.5 million for preliminary engineering; \$142 million for right of way & utility relocation; and \$60 million for construction.

VDOT is soliciting comments on its proposed plan. The current comment period closes on December 6. After that, revisions are expected, and a final proposal will be presented in Spring 2018.
