# HEADS UP PEDESTRIANS

- Cross with care. Make eye contact with drivers and wait until traffic has stopped before you cross.
- Pay attention. Avoid distractions like texting. Continue to look for traffic while you cross as drivers may not always stop or obey traffic signals.
- Get noticed! Wear bright clothes and reflective gear, especially in low light or poor weather.
- Be predictable. Use crosswalks and intersections. Never jaywalk.
- Extend your arm to indicate that you wish to cross.
- Where there are no sidewalks, always walk on the left side of the road facing traffic.
- Follow traffic signals.



- Always yield to pedestrians at intersections.
- Be alert and scan left and right for pedestrians when you approach any intersection.
- If a vehicle is stopped in front of you or in the lane next to you, they may be yielding for a pedestrian, so be prepared to stop.
- Always watch for pedestrians when you're backing up.
- Be aware of pedestrians who seem unsure or who may not be paying attention.



## **South Flow Alliance:**



Working together so we don't see these in our neighborhood

It's been a little over a year since we took up the issue of aircraft noise affecting daily life in HHV. At its meeting last June, the FAA thought they would have a solution to the issue by this time. But no solution has been implemented.

The newly formed South Flow Alliance, a group of Fort Hunt Road neighbors, is mounting an aggressive campaign to develop practical solutions to the issue. They have put out a call to all concerned to join them in working to quiet our skies. They invite all to help publicize the issue and work the political process.

HHVCA's involvement is important. Any solution must have a quieting effect for all neighborhoods, and not simply put the burden on others. If neighboring communities are successful in alleviating their noise problem, it may push flights further south. Our participation will at least give us a voice in expressing our concern and in crafting a positive outcome.
