Please read before accepting

As parent or guardian you hereby irrevocably grant Talk to the Camera (“TTTC”) the right to make VIDEO/AUDIO RECORDINGS AND/OR PHOTOGRAPHS of my child during TTTC workshops, classes, camps,, or Talk to the Camera events (i.e - Casting Calls, Red Carpet events, Ambassador filming) to be used by TTTC for the making of the class video and for TTTC marketing purposes. I, as parent or legal guardian, also irrevocably grant to TTTC, the right to use my child’s image in all forms and media for marketing purposes throughout the world. I waive the right to inspect or approve versions of said RECORDINGS AND/OR PHOTOGRAPHS.

TTTC warrants that materials produced during its workshops, classes, camps, and events will be used for educational purposes and that it will not sell those materials. TTTC may use some of the materials produced for marketing purposes including, but not limited to, print ads and brochures and brief video clips on the TTTC website and/or on TTTC’s public YouTube and Vimeo channels.
