1. TIME/LOCATION/PAYMENT

- a. The class is 9 hours in length and consists of three parts: (A PDF copy of the *Louisiana Concealed Handgun Permit Laws and Administrative Rules Booklet* will be provided to participants who have registered).
 - i. Program slides (6 Parts PDF), as well as a pre-online instruction "Learning Supplement" will be provided. Please review the slides, and the Louisiana State Police Concealed Handgun unit RULE BOOK. Reviewing the Rules Booklet and the Program Slides, and completing the learning supplement should take just over 2 hours to complete, and will need to be printed out and completed prior to the online instruction, scanned up, and returned to the instructor via e-mail. No participant will be admitted to the online portion of the class until the instructor has received the completed preonline instruction learning supplement. Participants will be asked to answer questions and discuss topics from the Learning Supplement during the online portion of the class.

- 2. ABOUT THE INSTRUCTOR & THE CLASS:
 - a. IMPORTANT SAFETY MESSAGE:
 - i. For Online Classes:
 - 1. PLEASE DO NOT BRING YOUR HANDGUN OR ANY LIVE AMMUNITION INTO THE AREA NEAR YOUR COMPUTER OR DEVICE WHERE YOU WILL BE RECEIVING ONLINE INSTRUCTION.
 - 2. WHEN YOU BRING YOUR HANDGUN INTO THE RANGE, BRING IT IN <u>UNLOADED</u>, <u>WITH THE ACTION OPEN</u>,



PREFERABLY IN A HOLSTER (THE ACTION PROBABLY CANNOT BE OPEN IF IN A HOLSTER—ENSURE HANDGUN IS UNLOADED—TRIPLE CHECK), CASE OR CONTAINER OR RANGE BAG.

- b. Louisiana Concealed Carry School began in 2013. The instructor, Randy McKinney, is a certified National Rifle Association (NRA) Basic Pistol Instructor, former law enforcement officer and Criminal Justice Instructor. He is a graduate of the North Delta Regional Law Enforcement Training Academy and the Louisiana State University Law Enforcement Institute. Randy has Masters' Degrees in Criminal Justice and Public Administration, along with 30 graduate hours in Adult Education. Randy, who is a licensed healthcare administrator/consultant and teacher at heart, has put together a professionally designed program for those who desire to carry concealed firearms for personal protection from all walks of life.
- c. Our curriculum was specifically designed for concealed carry in Louisiana--and is intended to meet the standards and guidelines set forth by Louisiana Law. Further, it is designed with the special knowledge in mind that is needed by those who have decided to carry a concealed handgun. In our classes we discuss forensic aspects of concealed carry; what to do if you become involved in a shooting--and what to expect. And most important: How to stay SAFE and alive--and out of prison.
- d. We base our entire curriculum and training on "doing the right thing" in order to avoid having to use force whenever possible (preventive measures), and to use force only whenever it is reasonable and necessary to "Stop A Threat," Safely--and Legally, so that you know that what was done was correct, that it was done for the right reason, and that it was accomplished in the right manner.
- e. Concealed Carry is a "lifestyle." It must be accomplished safely. As a Concealed Carry Permit licensee and as a father, I look forward to helping you to obtain the solid foundation needed to safely carry a concealed firearm--and to protect yourself, and your family if necessary.
- f. In addition, I hope that you will be motivated toward a commitment to lifelong learning and practice as you carry a firearm throughout the years. During these classes, you will gain skills that can be lost, if not regularly practiced.

3. REQUIREMENTS FOR SUCCESSFUL COMPLETION OF CLASS (TO BE ISSUED A CERTIFICATE)

- a. Participants are required to be present ONLINE for the entire time, except for breaks as needed. Participants will be required to have cameras "ON" so that instructor is able to ensure that participant is present and is receiving instruction as required by Louisiana Law.
- b. Learners may leave the online environment at any time but must notify the instructor upon leaving--and all time and subject matter must be made up prior to a certificate being issued.
 - i. Additional charges may be incurred if time has to be made up, and no certificate of course completion shall be issued by the instructor absent instruction time as required by Louisiana Law.
- c. Learners must demonstrate an attitude reflecting the level of safety and responsibility necessary to carry a handgun in public during the class. Participants must demonstrate to the instructor that they are willing to be safe and responsible.



d. PLEASE BRING 36 ROUNDS OF AMMO (At Minimum) FOR YOUR HANDGUN WITH YOU TO THE RANGE.


- **e.** <u>Shooters must successfully complete live range fire</u> which will include 12 rounds each at the following distances: (for a total of 36 rounds).
 - i. 6 feet
 - ii. 10 feet and
 - iii. 15 feet
 - 1. Each participant will perform at least one safe reload of the handgun at each distance.
 - 2. Each participant must score 100 percent hits within the silhouette portion of an N.R.A. B-27 law enforcement type silhouette target with 36 rounds.
 - a. If you have little or no experience at shooting a pistol, you are encouraged to have at least 72 rounds available at the range.
- f. While every participant is fully expected to easily meet these standards on the first attempt, the instructor is willing to work with participants who may have difficulties, to improve toward successful completion of this course. Such work may occur at a later time agreeable to the instructor and participant. In the end, however, any participant who is not able to hit a N.R.A. B-27 Target as required will not be issued a certificate.
 - i. Any participant not able to hit during the first 36 rounds will be moved to the end to avoid delaying other participants.
- g. Upon completion of the above, participants will be issued a certificate with the instructor's Louisiana State Police registration number and original signature affixed which is to be included with the applicant packet for the Louisiana Concealed Handgun Permit.

4. **RESPONSIBILITY**

- a. Louisiana Concealed Carry School is owned and operated by Randy McKinney, hereinafter referred to as "the instructor."
- b. While the instructor strives to properly research and communicate all areas that are legally required for concealed carry, due to issues and concerns involving technology, human error or unintentional oversight, the possibility does exist that needed information could be deleted from, overlooked, or miscommunicated by either the instructor or learners during this course of study.
- c. While a good faith effort is made by the instructor to facilitate the conveyance of all needed information to learners concerning the principles associated with concealed carry, it is ultimately the responsibility of the individual student to know and understand the laws and guidelines set forth concerning concealed carry issues.
 - i. Further, applicants to the Louisiana State Police for a concealed handgun permit must, upon application thereto, sign one affidavit, among others, stating that they have read and that they understand and agree to comply with certain Louisiana Statutes and Administrative Regulations concerning concealed carry in Louisiana. - d. It is the responsibility of the participant to use only that force which is reasonable, necessary, and lawful in any situation or circumstance. Louisiana Concealed



- Carry School is not responsible for the improper, negligent or unlawful conduct or behavior of any of learners, attendees or certificate holders, past, present or future, nor of any other party or parties connected to or associated with Louisiana Concealed Carry School or its instructor or students.
- e. The foundation for our classes is partially based on a learning environment where respect is present for all participants, and the experiences and opinions of all involved parties (learners and the instructor) are respected, mutually. With this type of environment, the instructor and learners should have an expectation that some participant learning may be based on the experiences of other participants within the class environment. This is a major premise of modern adult education. With this, the instructor will not accept responsibility for any statements made by any parties before, during or following classes-other than those made by the instructor himself.
- f. Safety is everyone's responsibility. Safety is communicated as a paramount value in our classes. Neither Louisiana Concealed Carry School nor the instructor will tolerate any act of negligence or carelessness made by any individual, nor will Louisiana Concealed Carry School or the instructor be held responsible for such act or acts. Any individual behaving in an unsafe manner, or exhibiting behavior which is negligent, careless or which gives the appearance of being inconsistent with the level of responsibility needed to safely and lawfully carry a handgun concealed in public will be offered a full refund of their registration fee and will be respectfully asked to leave the class. If such refund is accepted by any student who is asked to leave the class, the refund shall be issued within ten (10) business days. This shall be at the complete discretion of the instructor. A Concealed Handgun Permit Training Class must convey professional values of safety relating to firearms, and attitudes reflecting such values must be accepted and displayed by learners who are to be certified in this class.
- g. Our class is serious business. It involves the dissemination of a special type of information by the instructor, and it takes a special type of person to carry concealed who is able to do so safely--and without getting charged with a crime, convicted, and imprisoned in doing so. Again, carrying a handgun is an awesome personal responsibility, as well as a liability, if not respected.
- h. As the instructor for this course, it is my desire to lead you toward embracing concepts which may help to keep you from getting into a situation where you are forced to use your handgun.
- i. My priority is, as well, to assist you in embracing concepts and skills to help you to use your handgun, lawfully and effectively, if you find yourself in such a situation, so that you may protect your family--and yourself, if necessary.

HOW TO APPLY FOR A CONCEALED HANDGUN PERMIT

ALL FEES ARE NON-REFUNDABLE, and must be paid by money order, cashier's check, or certified check.

In an effort to allow the most efficient processing of your application, we suggest that you review the following tips for both new and renewal applications:

- 1. Review your application for completeness. An incomplete application may result in the delay or denial of your application.
- 2. Make sure all questions are answered correctly, specifically the questions with regard to arrests, medical conditions, and 18 USC 922 g. (See selected statutes in the <u>Law and Rule Booklet</u>.)
 - a. Read the arrest question carefully, as you must list all arrests, summons, and citations (except speeding citations) even if listed on a previous application. You must provide a certified true copy of all arrest dispositions with your application.
 - b. If you listed a medical condition you must have the treating physician complete the <u>medical</u> <u>summary form</u> before submitting your application.
 - c. If you are currently subject to a protective or restraining order you must provide a certified true copy with your application.

Original/First-Time Applicants:

In order to apply for a concealed handgun permit, a citizen should follow the steps below:

- 1. Apply for a Concealed Handgun Permit by one of the following ways:
 - a. Complete and submit the new online Concealed Handgun Permit Application at http://chp-web.dps.louisiana.gov.
 - b. Download a <u>Concealed Handgun Permit Application</u> and complete the instructions found on pages one and two of the application.
 - c. Obtain an application at the State Police Headquarters (7919 Independence Blvd., Baton Rouge, LA 70806) between the hours of 8:00 am and 4:30 pm, Monday through Friday.
- 2. Provide all necessary documentation pertaining to training, arrest dispositions, <u>medical summary dispositions</u>, and divorce decrees (if applicable). New fingerprints must be submitted for original/first time applicants. Old fingerprints on file will not be accepted.
- 3. Contact your local police office, local sheriff's department, or State Police Headquarters in Baton Rouge for fingerprinting. Fingerprinting at State Police Headquarters requires a \$10.00 money order or can be paid using a debit/credit card. Prints must be submitted on an **FBI Applicant** Fingerprint Card. The card should be completed as outlined in the application instructions. <u>Example</u>
- 4. Paper applications, fingerprint cards, and/or other documentation must be submitted to:

Renewals:

- 1. Permit holders will be notified in writing at their address of record, approximately 120 days prior to the expiration of their permit to begin the renewal process.
- 2. Upon notification, apply for a Concealed Handgun Permit by one of the following ways:
 - a. Complete and submit the new online Concealed Handgun Permit Application at http://chp-web.dps.louisiana.gov.
 - b. Download a <u>Concealed Handgun Permit Application</u> and complete the instructions found on pages one and two of the application.



- c. Obtain an application at the State Police Headquarters (7919 Independence Blvd., Baton Rouge, LA 70806) between the hours of 8:00 am and 4:30 pm, Monday through Friday.
- Submit the renewal application with a new training certificate, a photocopy of your driver's license, and the <u>appropriate fees</u>. NOTE: Passport photos are no longer needed to process your applications. Submission of a fingerprint card is not needed for renewal applications.
- 4. The completed application should be returned to the Department no less than 90 days prior to the expiration of the permit to allow sufficient time for processing.
- 5. You must submit your application within 60 days after the expiration date or you will be required to submit a new original application including fingerprints.
- 6. Paper applications and/or other documentation must be submitted to:

FEES

Five Year Permit (Original and Renewals):

Ages 21 - 64: \$125 65 or Older: \$62.50

Lifetime Permit: Ages 21 - 64: \$500 65 or Older \$250

NOTE:

- If you have not continuously resided within the State of Louisiana for the 15 years immediately preceding the date on which your
 application is received, an additional \$50 non-refundable fee shall be submitted. This is only for first-time applicants and is not required for
 any subsequent renewals.
- 2. If you apply online, you will receive an email once your application has been accepted. This email will contain a link to pay for the permit by credit card. If you do not remit payment within thirty (30) days of receiving the payment link, your application will be purged from the system and will require a new submission to proceed.

Military Discount

If you are currently in the military and wish to use the military discount, you must include a copy of your most recent orders.

Five Year Permit: \$62.50 Lifetime Permit: \$250

Veterans

Veterans with an honorable discharge are fee exempt.

TRAINING

Original/First-Time Applicants:



In addition to meeting the qualifications in R.S. 40:1379.3(C), an applicant must demonstrate competence with a handgun by completion of an approved firearms safety or training course taught by an NRA or P.O.S.T. certified instructor that is registered with State Police, or completion of small arms training while serving in the military (as evidenced by a DD-214), [active service members, reservist and national guard members must include a clear photocopy of their military ID (front & back) with a copy of their last qualification record from their 201 file], or possession of a current valid license to carry a concealed weapon issued by a parish law enforcement officer.

Lifetime permit holders are required to complete refresher training every five years as required by LRS 40:1379.3.(V)(4).

Renewals:

Pursuant to LAC 55:I:1307.D, each permittee applying for a renewal of his permit shall complete additional educational training within one year prior to submitting a renewal application. To obtain renewal training, please contact one of the LSP registered instructors.

ADDITIONAL INFORMATION

(COPIED FROM THE LOUISIANA STATE POLICE WEBSITE AUGUST 2020)

PROHIBITED LOCATIONS

R.S. 40:1379.3 (N) states that no concealed handgun may be carried into and no concealed handgun permit issued pursuant to this Section shall authorize or entitle a permittee to carry a concealed handgun in any of the following:

- A law enforcement office, station, or building;
- A detention facility, prison, or jail;
- A courthouse or courtroom, provided that a judge may carry such a weapon in his own courtroom;
- A polling place;
- A meeting place of the governing authority of a political subdivision;
- The state capitol building;
- Any portion of an airport facility where the carrying of firearms is prohibited under federal law, except that
 no person shall be prohibited from carrying any legal firearm into the terminal, if the firearm is encased
 for shipment, for the purpose of checking such firearm as lawful baggage;
- Any church, synagogue, mosque or similar place of worship; See RS 40:1379.3 (U)
- A parade or demonstration for which a permit is issued by a governmental entity;
- Any portion of the permitted area of an establishment that has been granted a Class A-General retail
 permit, as defined in Part II of Chapter 1 or Part II of Chapter 2 of Title 26 of the Louisiana Revised
 Statutes of 1950, to sell alcoholic beverages for consumption on the premises.
- Any school "firearm free zone" as defined in R.S. 14:95.6.

The provisions of R.S. 40:1379.3 (N) shall not limit the right of a property owner, lessee, or other lawful custodian to prohibit or restrict access of those persons possessing a concealed handgun pursuant to a permit issued under this Section. No individual to whom a concealed handgun permit is issued may carry such concealed handgun into the private residence of another without first receiving the consent of that person.

DUTIES OF PERMITTEES



The permit shall be retained by the permittee who shall immediately produce it upon the request of any law enforcement officer. Anyone who fails to do so shall be fined not more than one hundred dollars. Additionally, when any peace officer approaches a permittee in an official manner or with an identified purpose, the permittee shall:

- 1. Notify the officer that he has a weapon on his person;
- 2. Submit to a pat down;
- 3. Allow the officer to temporarily disarm him.

A permittee may not carry and conceal a handgun while under the influence of alcohol or a controlled dangerous substance (CDS) as defined in R.S. 40:961 and 964. For purposes of the concealed handgun law, a permittee is considered under the influence of alcohol when a blood alcohol reading of .05% or greater by weight of alcohol in the blood is obtained, or a blood or urine test shows any confirmed presence of a CDS.

The permit to carry a concealed handgun shall be revoked by the deputy secretary when the permittee is carrying and concealing a handgun under any of the following circumstances:

- 1. The blood alcohol reading of the permittee is .05% or greater by weight of alcohol in the blood;
- 2. The permittee's blood test or urine test shows the confirmed presence of a CDS as defined in R.S. 40:961 and 964;
- 3. The permittee refuses to submit to a department certified chemical test when requested to do so by a law enforcement officer.

R.S. 40:1379.3(L) provides that anyone who carries and conceals a handgun in violation of any provision of this Section, unless authorized to do so by another provision of the law, shall be fined not more than five hundred dollars, or imprisoned for not more than six months, or both.

R.S. 40:1379.3(C)(1) requires the making of a sworn application to the deputy secretary of public safety services of the Department of Public Safety and Corrections. The providing of false or misleading information on the application or any documents submitted with the application shall be grounds for the denial or revocation of a concealed handgun permit. The application shall reflect training in pistols, revolvers, or both. Any permittee under this Section shall notify the department of any address or name change within thirty days of the change. Failure to timely notify the department of a name or address change may result in suspension of the permit for up to thirty days.

R.S. 40:1379.3(R)(1) requires each permittee, within fifteen days of a misdemeanor or a felony arrest, other than a minor traffic violation, in this state or any other state, shall notify the deputy secretary of public safety services by certified mail. The deputy secretary may suspend, for up to ninety days, the permit of any permittee who fails to meet the notification requirements of this Section.

R.S. 40:1379.3(F)(1) mandates that the deputy secretary shall revoke the permit if at any time during the permit period the permittee fails to satisfy any one of the qualification requirements provided for in Subsection C of R.S. 40:1379.3.

RECIPROCITY

Effective August 15, 2004, the concealed handgun laws were amended concerning reciprocity with other states. The statute provides as follows:


"...A current and valid concealed handgun permit issued by another state shall be deemed to be valid within this state if a current and valid concealed handgun permit issued by Louisiana is valid in those states." Louisiana law requires residents of the State of Louisiana to possess a Louisiana permit to carry a concealed weapon in this state. Louisiana law does not prohibit residents from obtaining permits from other states to carry in those states. Pursuant to R.S. 40:1379.3(T)(1) a valid permit in another state is valid in Louisiana if the issuing state honors

concealed handgun permits issued by Louisiana.

Permit holders are reminded that while carrying a concealed handgun in another state they are bound by that

state's laws governing concealed carry and permittees from other reciprocal states are bound by <u>Louisiana</u> <u>concealed carry laws</u> while in Louisiana.
